Revision 1	<p>We have amended the Scottish Carer’s Assistance spending forecast, and the Carer’s Assistance Supplement caseload forecast. These amendments do not affect our headline social security spending forecast.</p> <p>1. We included the knock-on effect of the introduction of Scottish Carer’s Assistance to Carer’s Assistance Supplement as part of the additional cost to the baseline Scottish Carer’s Assistance. Instead, this should have been part of the Carer’s Assistance Supplement spending forecast.</p> <p>2.
